Sub: Intimation regarding the court order of Hon'ble NCLT applying the Corporate Insolvency Resolution Proceedings and thus appointment of Interim Resolution Professional under Insolvency and Bankruptcy code, 2016 in the matter of THREE C PROJECTS PRIVATE LIMITED.

Reg: 1. Vide section 14(2) of the IBC 2016 read with Regulation 32 of the Insolvency & Bankruptcy Regulation, 2016 , the supply of Essential Goods or Services to the Corporate Debtor shall not be terminated or suspended or interrupted during the Corporate Insolvency Resolution Proceeding period

2. Pending Electricity Bill (A/c No. T.C. 1170K) of Rs 3362421/- of Project "Lotus Zing" in the Name of Company "Three C Projects PVT. LTD." for the property situated at GH-01/A, Sector-168, Noida, Gautam Budh Nagar, Uttar Pradesh.

This is with reference to the captioned subject in which the National company Law Tribunal (NCLT) vide its order dated 28.08.2019 appointed Mr. Manish Kumar Gupta (Registration Number: IBBI/IPA-001/IP-P00225/2017-18/10424) as the Interim Resolution Professional (IRP) under the Insolvency and Bankruptcy code, 2016 (IBC) for initiation of Corporate Insolvency Resolution Process (CIRP) of the corporate Debtor i.e. THREE C PROJECTS PRIVATE LIMITED (hereinafter referred to as Corporate Debtor). The court order of the NCLT is attached for your reference.

In view of the above the IRP shall be vested with the management of affairs of the Corporate Debtor and all the powers of the Board of directors of the Corporate debtor shall stand suspended with immediate effect and be exercised by the IRP. Moreover, IRP has to keep the Company active and going concern as per Sec-20 of the IBC, 2016

Further, as per section 14(2) of the IBC 2016 read with Regulation 32 of the Insolvency & Bankruptcy Regulation, 2016, the supply of Essential Goods or Services to the Corporate Debtor shall not be terminated or suspended or interrupted during the Corporate Insolvency Resolution Proceedings (CIRP) period. The essential goods and services referred to in section 14(2) shall mean Electricity; Water; Telecommunication services; and Information technology services.

The order of CIRP shall have effect from 28.08.2019 for 180 days i.e. 27.02.2020 plus further period of 90 days in case extended by the Hon'ble NCLT Court.

Therefore in compliance of the prevalent Law as referred above and the relevant order by NCLT attached herewith, you are hereby directed to ensure the uninterrupted supply of Electricity (essential services) to the Corporate Debtors during the said Corporate Insolvency Resolution Proceedings (CIRP) period and Supply of Electricity being one of the essential services as per Regulation 32 of IBC, so its uninterrupted supply is a must during CIRP.
