Form B – For claims by Operational Creditors (except Workmen and employees); **Form C** – For claims by Financial Creditors, **Form CA** – For claims by Financial Creditors in class as aforesaid, **Form D** – For claims by Workmen and Employees, **Form E** – For claims by Authorized Representative of Workmen and Employees, **Form F** – For claims by Creditors other than Financial Creditors and Operational Creditors.

Submission of false or misleading proofs of claim shall attract penalties.
